Above all, we are committed to providing an environment where everyone is protected from any form of abuse/harm, neglect or inappropriate behaviour. At the Y we believe in the power of inspired young people. For young people to be inspired, we know they need to feel safe and be safe.

The role is supported by a Safeguarding Sub-Committee and reports directly to the Board. The Board has also developed a Safeguarding commitment statement.

Our Y has developed strong processes and procedures to help keep children and young people safe. We have clear policies, stringent employment procedures including Working with Children Checks, as well as regular staff training.

All staff complete a Safeguarding induction, are trained in our National Safe Behaviors, and must abide by this Safeguarding Code of Conduct

We are pleased that Y Brisbane are working with the Australian Childhood Foundation (ACF) to review our Safeguarding practices and procedures.

Safeguarding Framework

The Y has a culture of awareness supported by:

- At the heart of our Safeguarding Framework is our Safeguarding Vision, to 'feel safe, be safe.'
- Our Safeguarding Vision stands on three
 Pillars: Culture, Operations and Environment
- Clear documented Safeguarding policies
 and procedures
- Incident reporting, management and a culture of continuous improvement
- A focus on staff and volunteers documenting any concerns they may have
- A culture of if you see something, hear something or feel something... tell someone

Recruitment Practices

We require staff and volunteers to undergo an extensive screening process prior to appointment. Successful applicants must:

- Maintain a current Working with Children Check
- Complete a face to face interview that includes Safeguarding questions
- Pass two reference checks
- Complete the YMCA Safeguarding Children and Young People Induction Course introduction training into YMCA Safeguarding policies & procedures, Safe Behaviours- Code of Conduct, and the importance of Safeguarding children and young people at the Y.


